At this time there are no reference standards available for (+)- δ^8 -THC. (+)- δ^8 -THC is a different compound from the main (-)- δ^8 -THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)- δ^8 -THC and d^9 -THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)- δ^8 -THC and d^9 -THC with the majority, if not all, of the concentration being (+)- δ^8 -THC. Total (+/-) δ^8 Concentration is estimated to be: 73.68%
